
Possible Criteria for Judging a Referendum

- Does it bring public policy into line with public preferences?
 - Assumes voters have clearly developed views
- Are the public's preferences implemented?
 - Assumes preferences are clear from the outcome
 - Assumes that, even if it wishes to do so, the state has the capacity to deliver

Three Questions to Ask of the Brexit Process


- What did voters want?
- What do they think of the outcome (so far)
- Are voters still of the same mind as they were in June 2016?

Attitudes towards Free Trade with the EU





Attitudes towards Treating EU Migrants like non-EU Migrants



Opinium: Single Market vs Free Movement




ORB: Immigration Control More Important than Free Trade



The Possible Trade-Off






Remainers and Leavers Have Different Priorities - 1




Chequers: A First Attempt At Compromise










Do you agree or disagree that the Prime Minister will get the right deal for Britain in the Brexit negotiations?





A Persistent Expectation






But Leavers and Remainers Have Very Different Perceptions

Support or Oppose The Deal?













Hiding A Polarised Structure





An Explicit Search for Compromise











Conclusion

- Delivering a Brexit that would satisfy most voters was never going to be easy
 - Given ending free movement but remaining in single market was ruled out by the EU, voters were always likely to polarise
- So far no compromise has emerged that seems capable of bridging the Remain/Leave divide
 - They all run the risk of appearing friendless
- Voters have become increasingly pessimistic about the outcome
 - But there has only been a small movement to Remain occasioned primarily by the view of abstainers
